By accepting this assignment of the Free Lot, the developer does hereby agree to follow these guidelines:

1. To erect a new home within one year of this agreement.
  - a. Within 120 days of the agreement the developer should have a signed contract with the builder or Manufactured home company, and have financing arranged. If applicant is building their own home, the developer should have plans drawn and financing arranged.
  - b. Within 180 days construction should be started so completion can be finalized within a one-year time frame.
2. The developer agrees to reside in the home as their primary residence for a period of at least one year after completion.
3. The developer agrees to abide by the covenants filed for the Westridge Addition.
4. Upon presentation of a signed contract and written notice by the developer to the City of Marquette, Kansas, that they are ready to begin construction, a title will be conveyed by the City of Marquette to the developer. All closing costs will be borne by the developer.
5. All special assessments on the lots will be financed by the City of Marquette, Kansas and placed on the property tax statement for the lots for a period of 20 years. The assessments will be billed the same as ordinary property taxes.
